[16 Legal Medical Marijuana States and DC](#) - On Apr. 11, 2012, Arizona released its revised rules for regulating medical marijuana and announced that it will be accepting dispensary applications. The Apr. 2012 Delaware Register of Regulations included proposed regulations for the Delaware medical marijuana program. See these and other laws, fees, and possession limits in the 16 states and District of Columbia that have legalized medical marijuana.

[Candidate Finances](#) - According to the Federal Election Commission, the three remaining Republican candidates (Gingrich, Paul, and Romney) have raised \$148,098,413 cumulatively, while Democratic President Barack Obama has raised \$196,610,770. See how much money each candidate, including third party and independent candidates, has raised and spent, where the money came from, and how much money each candidate currently has on hand.

[Is nuclear power safe for humans and the environment?](#) - Read statements, including post-Fukushima quotes, from experts such as John Hutton, Chairman of the Nuclear Industry Association (pro), Helen Caldicott, President of the Nuclear Policy Research Institute (con), the US Department of Energy (pro), and the Dalai Lama and nine other Nobel Laureates (con).
